Mitch will be offering four 6-day training camps in 2020 at Canvasback Kennels in Camden, SC. Training camps will be held Sunday through Friday beginning at 9 am and continuing until late afternoon/evening. Each handler/dog team will receive individual instruction directly from Mitch on set ups he will design to challenge and progress your dog.

All levels of dogs are encouraged. All sporting breeds are welcome. Handlers may run up to two dogs per camp. Cost per handler is \$600.00. If you desire to run more than two dogs, a second handler spot may be purchased. A maximum of 10 handler spots are available for each camp. All handlers are required to participate in setting up and breaking down equipment and in training prep activities unless prevented by handicap. Mitch will not run client or personal dogs during training camp hours unless they are needed for demo, mechanics or test dog purposes.

There will be a host dinner on site one evening during camp. Other evenings will include dinners out at local restaurants, a pot luck and some downtime to explore the area on your own. Bring drinks, snacks and your own lunch to get you through the day as there will be no formal lunch breaks so we can keep working your dogs.
