A solid foundation of basic retrieving skills is essential for the future success of you and your dog. Mitch will help you to develop a program for you and your dog to build a strong foundation for your dog. Then he will show you how to build on that foundation with the drills and skills needed to take you through Senior and on to Master.

This workshop will start with a review of all the basics. Essential for new dogs and handlers, as well as a great review for those further along, the basics review will help you get started or help you identify areas of weakness in your dog's foundation training. Mitch will then spend an entire day on drills. Drills are great for dogs of all levels and the drills presented will cover all levels, basic – transition – advanced. The workshop will end by covering the advanced skills needed to succeed in at the master level.



### Mitch White, Gamekeepers Retrievers Head Field Trainer:

Mitch has been training retrievers for field work since 1988. A true student of the game, Mitch has developed a program that goes outside the box to enable all breeds of retrievers to succeed at the highest level. Directions: From I-25 exit 250 onto Hwy 56. West on Hwy 56 (9 miles) continuing through Berthoud and across Hwy 287 until the Hwy turns north on N CoRd 23. North on N CoRd 23 1/2 mile then west on CoRd 8e toward Carter Lake. Continue on CoRd 8e approximately 4 miles, after you pass the Carter Lake pay station, the road will switchback up the ridge, at the first intersection, stay to the left and continue around the south side of Carter Lake on S CoRd 31. You will see the campgrounds and south side boat ramp on the west side of the road. Follow the road south from the lake staying to the right when there is a parallel split. CoRd 31 S ends at Dorband's property and we will have signs out about where to park.

From helping new dogs and handlers get started, to working with more experienced dogs to identify and repair any holes in foundation work. Day will end with a Q&A discussion.

**SATURDAY:** Workshop will begin at 9:00 am with a brief Q&A covering the previous day's work. Mitch will then spend the day teaching drills for all levels of work, from basic to advanced marking drills, lining drills, drills for water work and more.

**SUNDAY:** 9:00 am Brief discussion of previous day's work with Q&A. Day three will focus on Advanced level work appropriate for dogs beginning master work to seasoned competitors. Q&A, discussion and final address will be held at the conclusion of the workshop.
