All levels of dogs are encouraged. All sporting breeds are welcome. Handlers may run up to two dogs per camp. Cost per handler is \$450.00. If you desire to run more than two dogs, a second handler spot may be purchased. A maximum of 10 handler spots are available for each camp. All handlers are required to participate in setting up and breaking down equipment and in training prep activities unless prevented by handicap. Mitch will not run client or personal dogs during training camp hours unless they are needed for demo, mechanics or test dog purposes. Camp will be held at Gamekeepers and surrounding training properties. Land and water work as well as yard work and drills will be covered.
